ii) Eligibility:

Should have passed, Bachelor's degree under 10+2+3 pattern in Physical, and Biological Sciences OR Bachelors degree in Agricultural, Veterinary and Fishery Science, Pharmacy, Engineering/Technology or Medicine (MBBS) or BDS from the University of Kashmir or any other Institute recognized by UGC with at least 55% marks in aggregate for Open Merit and 50% marks for reserved categories by or before **10.11.2021**.

iii) Admission Criteria:

Candidates shall be admitted to the programme on the basis of GAT-B score 2021...

v) Submission of Online Application Forms:

The candidates are advised to follow below mentioned steps for filling their Online Application Forms: -

Step-6: If there is any variation click on <u>"Previous"</u> button, make necessary corrections and then Click <u>"Submit"</u>. Get a printout of the Form and retain it for reference and record.

vi) Submission of downloaded Application Forms (Hard copy):

After submitting the Online Application Form, candidate need not to submit the downloaded Form (hard copy) but should retain with themselves for future reference.

vii) Verification of documents/certificates:

- Department of Biotechnology will check/verify the educational/category certificates etc. of the candidates at the time of admission and it will be the sole responsibility of the candidate to satisfy whether he/she is meeting the prescribed criterion.
